 a) Public Toilets, Rhayader
 Cllr Curry informed members that Rhayader Town Council is still in discussions with PCC over this matter.

NC 03/14 Planning Applications:

- a) P2013/1220 Full: Micro Hydro Development (renovation of the former hydro electric generating station) at Argoed Mill, Doldowlod for Mr DJ Gibson-Watt. <u>Cllr Curry declared an interest in this matter and left the room</u> whilst discussions took place. No objection.
- b) P2014/0026- Full: Installation of a wind turbine with a hub height of 36.7m and blade tip height of 47.1m (grid ref 301585 263376) and construction of length of track, at Upper Cilgee for Urban Wind. <u>Cllr Curry declared an interest in this matter and left the room whilst discussions took place</u> Resolved: to object to this application due to the negative visual impact this will have on the community of Nantmel.
- c) P2014/0016 Variation of condition: Variation of condition 1 planning consent P.2008/0029 to extend time limit for commencement of development land at Wernfach, Nant Glas for Mr W Collard. . <u>Cllr Curry declared an interest in this matter and left the room whilst discussions took place.</u> No objection

d) A470, Turn to Llanwrthwl

Cllr Bowen had received several complaints from local residents who are being forced to pull into the layby prior to turning right over the bridge to Llanwrthwl due to the speed of traffic behind them. Members agreed this was a 'fast' stretch of road often used for overtaking. Members agreed there was little that could be done about this matter.

e) Powys Windfarm Signs

Cllr Bowen had received complaints about the 'Powys Windfarm Signs' which are hung on telegraph poles on A470. Members felt that these were not official signs. Cllr Bowen felt that they were misleading.

Resolved: to contact British Telecom regarding these.
