a) Pont Elan Bridge

Cllr Curry had previously informed members that there would be a weight limit of 7.5 tonne placed on this bridge. There were plans to refurbish the stone bridge, however recently it was found that the Bailey bridge was badly corroded, hence the weight limit being placed. Plans have now changed and it is planned to source replacement parts to fabricate the Bailey bridge in due course, this will involve a road closure of approximately one week, but once repairs have been carried out the weight limit will be lifted to 26 tonnes. This was welcomed by members.
