War Memorial

The Clerk and Cllr Curry had obtained the following information from Nathan Davies, PCC's War Memorials Officer.

The Powys War Memorials Project can provide a maximum of £2700 for repair and restoration works to individual World War 1 war memorials in Powys. This will be provided to a maximum of 90% of the total cost of the approved works. Local communities, such as Town and Community Councils, third sector organisations or churches, need to find and confirm match-funding for the outstanding amount.

The project can also provide a maximum of £200 for improvement works to war memorial surroundings, such as fences, railings or lighting. This will be provided to a maximum of 70% of the total cost of the works. Local communities will need to match-fund the outstanding amount. The project can support communities, if needed, to find and apply for match-funding.

Resolved: Clerk to meet with Nathan Davies at the War Memorial to discuss the refurbishment programme.
