a) Powys County Council - Recycling Point, Nantmel

b) Powys County Council - LDP Consultation

Following the submission of the Powys Local Development Plan to the Welsh Government and the Planning Inspectorate for Public Examination in January 2016 and following the Exploratory Meeting held with the appointed Inspector, Mrs Nicola Gulley, on May 10^{th} 2016, Powys County Council is undertaking a further period of public consultation on a proposed **Schedule of Further Focussed Changes October 2016**.

The Further Focussed Changes are subject to a formal **6 week public** consultation between Monday **10**th October and **5.30 pm** Monday **21**st November **2016**. NC 65/16 Future Meetings - Nantmel School

The Clerk had contacted the Diocese on 2 occasions but had received little detailed information. She then contacted the Tim Davenport, Diocesan Registrar and obtained the following information:

- 1. The School belongs to the Educational Trusts of the Swansea & Brecon Diocesan Trust (Incorporated), a registered charity the charitable purposes of which are to provide education in the Diocese of Swansea & Brecon.
- 2. Powys County Council as the Education Authority use the Trust land and buildings until such time as they decide (as they have now done) that they will provide alternative education arrangements for the area. However until the School is actually closed and the Council have removed their possessions and handed the building back to the Trust nothing can be done.
- 3. Once the School is handed back to the Trust the Trust has to deal with the land for the charitable purposes, ie the provision of education in the Diocese. This can be achieved either by selling the site and using the capital raised or by renting it out for a commercial rent and using the income (rent) for those same purposes.
- 4. A decision about what will be done will take place after the school has been handed back (which can take up to six to 12 months from closure) with professional advice being taken on the options.
- 5. It is not possible to simply give the School to anybody. It has to be a commercial transaction in the best interests of the charitable trusts. This is not negotiable. We will be bound by Charity Law.

If the community want to use the building after the School has closed then they could negotiate to buy it or to rent it and those proposals would be considered alongside the professional advice.

Members discussed this matter at length and it was agreed to hold a Public Meeting at 7pm on Thursday 17th November to discuss the future use of the building. Members would publicise this meeting and the Clerk will contact the press and local groups to encourage people to attend. The Community Council will then make a decision with regard to entering into discussions with the Diocesan. Cty Cllr Bowen will speak with Rev Helen Rees, Director of Education for the Diocesan to establish further information.

Resolved: It was also decided that member of the Community Council will meet up on Sunday 6th November at 1.30pm to sort out the shed and label up all Council and community property to prevent its removal by

Powys County Council. The Clerk will print labels for the day. The Clerk will also look into the possibility for the Community Council to take out a public loan.

NC 66/06 Any Other Business

a) War Memorial

Cllr Bowen had spoken to Maldwyn Wozencraft to ask for a quote for the work on the War Memorial. The Clerk had not received this. **Resolved:** Clerk to contact Mr Wozencraft directly.

b) Cash Machine

Cllr Bowen congratulated Cllr Curry for his involvement in getting a cash machine installed at the Smithfield. There have been some teething problems but on the whole this has been well received within the community.

c) Defibrillator

Cllr Curry informed members that a Defibrillator has now been installed on the shed at Ashfield which was funded by Rhayader & District Defibrillator Group and with a donation from Nantmel Show Committee. Thanks go to Margaret Thomas for allowing the machine to be sited on her property. Training will be arranged short.
